**APPLE INDUSTRY BUSINESS MEMBERSHIP**  
All firms that handle apples beyond growing, such as packers, shippers, sales agencies, brokers, retailers, importers, exporters, processors, etc. Dues rates are based on the volume of apples grown, packed, processed or sold annually. These members are entitled to vote on association matters.
